The Washington State Minority and Justice Commission is pleased to host the 20th Annual Meeting of the National Consortium on Racial and Ethnic Fairness in the Courts at the Sheraton Seattle Hotel in Seattle, Washington from April 29 to May 2, 2008.

The Washington State Commission joined with the then only existing commissions (created by the highest courts of their States) in New York, Michigan and New Jersey to establish the National Consortium in 1987. From that beginning the Consortium has grown with representation of at least 30 State commissions which will be represented at this 20th Annual Meeting.

The Washington State Minority and Justice Commission was established by the Washington State Supreme Court in 1987 initially as the Minority and Justice Task Force. It was established as a Commission by court order in 1990 for five years with subsequent renewal orders in 1995, 2000 and 2005 (through the year 2010). In sponsoring the Minority and Justice Commission the Supreme Court acknowledges there is a continuing need to identify and eradicate all racial, ethnic, religious and cultural bias from our State court system.

The Washington State Commission is chaired by Associate Chief Justice Charles W. Johnson and retired Justice Charles Z. Smith. Its members are appointed by the Supreme Court and its technical support members are appointed by the Commission. Members consist of State and Federal judges, law school deans and professors, lawyers, administrators and other lay persons.

The Washington State Minority and Justice Commission and the Washington State Supreme Court welcome the National Consortium, its Moderator, Justice Marilyn Kelly, its Moderator-Elect, Judge Clarence J. Jones, its Board of Directors and all participants in this 20th Annual Meeting in Seattle.
